**Review RFP 1143 Proposals**

Discussion of Proposal 1 included budget, connection to school districts, partner agency staffing and capacity. Discussion of Proposal 2 included outcomes. Discussion of Proposal 3 included early intervention and impact. Proposal 4 was not discussed as it didn't pass fiscal review. Discussion of Proposal 5 included the number of points of service contact per dollar and provision of service to populations not usually targeted as well as evaluation. Discussion of Proposal 6 included the small number of recipients proposed and sustainability. Discussion of Proposal 7 included execution and staffing plan concerns. Discussion of Proposal 8 included target population, use of interns, and connection to schools. Discussion of Proposal 9 included collaboration and outcomes. Proposals 10, 11 and 12 were not reviewed due to fiscal scores.

**Funding Recommendations**

The committee will consider "innovation" awards and release a future RFI. Discussion to continue at the June FACT meeting. There was discussion of the funding level for proposal 1 and proposal 8.

Belinda moved to fund proposal 5 at \$80,000 and Karin seconded. The motion passed unanimously.

Lisa moved to fund proposal 3 at \$80,000 and Joe seconded. The motion passed unanimously.

Joe moved to fund proposal 8 at \$100,000 and Olga seconded. The motion passed unanimously.

Debra moved to fund proposal 2 at \$80,000 and Ruth seconded. The motion passed unanimously.

Simone moved to fund proposal 1 at up to \$102,551 and Deborah seconded. The motion passed unanimously.

Simone moved to fund proposal 9 at \$79,570 and Belinda seconded. The motion passed. **Yea:** Belinda Lucey, Karin Kauzer, Ruth Fernandez, Olga Jones, Lisa Johnson,

Debra moved to not fund proposal 7 and Simone seconded. The motion passed. Debra moved to not fund proposal 6 and Karin seconded. The motion passed unanimously.

\$522,121 total funds discussed and approved for potential FACT awards. All final funding based on contract negotiation; not to exceed Committee approvals.
