The vacancies previously tracked under Monitoring Report C-17-008 will now be transferred and all current vacancies will be tracked under C-18-008.

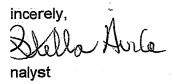

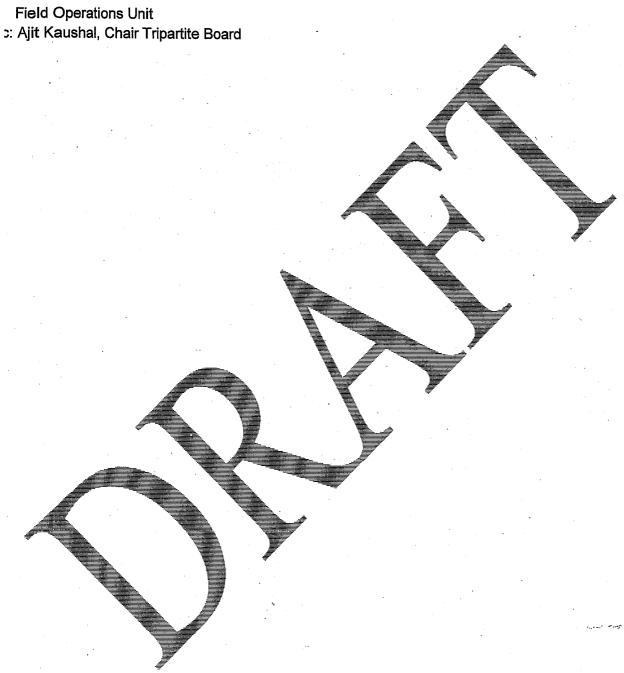
