





The Contra Costa County Economic Opportunity Council (EOC) is a mandated tripartite board of the Community Action Agency (CAA) responsible for administering the Community Services Block Grant (CSBG). The Employment and Human Services Department's (EHSD) Community Services Bureau (CSB) is the Federal and State recognized public entity for the CAA of Contra Costa County.

The Economic Opportunity Council of Contra Costa County was created during the Johnson Administration with the passage of the Economic Opportunity Act of 1964 also know as the "War on Poverty" legislation. The EOA mandated at minimum a 15-member board with five representatives from each of three sectors—low income, private/non-profit and the public. In Contra Costa County, each Supervisor appoints a public sector representative from his/her district.

## What do we do?

The Economic Opportunity Council administers the Community Services Block Grant Program and participates actively in the development, planning, implementation, and evaluation of the CSBG.

The Board holds public hearings every two years to identify priority areas and develop strategic plans that address the most pressing needs of the County's lowincome populations. Identified priority areas typically focus on affordable housing needs, employment training and jobs, health care, food insecurity, and the barriers that limit access to services.

Through legislative and policy actions, educational roundtable discussions, and outreach activities, the EOC works through its members and agency partners to advocate for and engage the poor and underserved.

#### Who are we?

The Economic Opportunity Council (EOC) is made up of 15 Contra Costa County community members representing the public, low income, private, and non-profit sectors. The EOC works with the Community Services Bureau (CSB) staff in the Employment and Human Services Department. The Contra Costa County CSB is the federal and state recognized public entity for the Community Action Agency.

Established in 1964 as part of President Lyndon Johnson's "War on Poverty" legislation, the EOC is part of a national Community Action Partnership network and is responsible for administering the Community Services Block Grant (CSBG).

#### What do we do?

The EOC works through its members and county agency partners to advocate for and to engage with low income and underserved families. Every two years, the EOC holds public hearings identify priority initiatives of the County's low-income populations, including affordable housing, employment training, well-paying jobs, health care, food insecurity, and the barriers that limit access to services.

The EOC and CSBG team take the input and develops an annual Community Action Plan (CAP). To achieve the CAP objectives, the EOC awards grants and provides technical assistance to the local CSBG subrecipients, which include County agencies and local nonprofit service providers.

The EOC holds an annual CSBG Service Provider Roundtable, which provides an opportunity for the subrecipients to network, share program information, and discuss the challenges facing our clients and community.

#### Why do we do it?

To give a voice and resources to our underserved community members. To give hope to low income families. To promote pathways out of poverty. To open the doors to self-sufficiency and full participation for everyone.
