- **Funding Secured: \$5,107,202** in total grant funding
- **Active Grants, FY 2019-2020: 9** grants & allocations awarded from federal and state agencies, securing **18+** grant awards worth more than **\$11.9M** since 2015 for Contra Costa County EHSD

Awarded Federal, State and Foundation Grants

- ✓ **Cal OES XC Grant: Elder Abuse Prevention Project (EAPP)—\$514,655** to provide a comprehensive and coordinated system of care for victims of elder abuse. Grant term: 1/1/2020 to 12/31/2020
- ✓ **Cal OES XE Grant: Elder Abuse Prevention Project (EAPP)—\$250,000** to enhance the safety of elder and dependent adult victims of crime by providing direct services to victims and bridging the gap between elder justice and victim service providers. Grant term: 1/1/2020 to 12/31/2020
- ✓ **Head Start Central Kitchen Project: Dean & Margaret Leshar Foundation—\$50,000** to build new central kitchen facility for EHSD Community Services Bureau's 16 Head Start program sites. Grant term: 7/1/2019 to 6/30/2020

- ✓ **APS Home Safe Program: CA Department of Social Services (CDSS) Housing Bureau—\$740,079** for 2 years to provide housing subsidies for APS older adults who are at-risk or literally homeless. Grant term: 5/1/2019 to 6/30/2021
- ✓ **Housing & Disability Advocacy Program (HDAP): CA Department of Social Services (CDSS) Housing Bureau—\$1,802,111** to provide outreach, case management, disability advocacy and housing navigation and placement services to GA clients who are homeless. Grant term: 1/1/2018 to 6/30/2021
- ✓ **Housing Navigators Program (HNP): CA Department of Housing & Community Development (HCD)—\$115,000** to provide housing navigation services to TAY, runaway and homeless youth. Grant term: 7/1/2020 to 12/31/2021
- ✓ **Medi-Cal Health Navigators Program: CA Department of Health Care Services—\$1,385,957** for Medi-Cal outreach, enrollment and retention activities for 7,000 immigrant families and homeless individuals. Grant term: 1/1/2020 to 12/31/2021
- ✓ **Transitional Housing Program (THP+): CA Department of Housing & Community Development (HCD)—\$113,600** to provide transitional housing to TAY, runaway and homeless foster youth. Grant term: 7/1/2020 to 6/30/2022
