The Department of Community Services and Development (CSD) has not received your 2023 Community Services Block Grant (CSBG) Contract and Associated Deliverables, or your 2022 CSBG Discretionary Contract and Associated Deliverables. This letter is to advise you that your agency has failed to meet contractual requirements set forth in the 2023 Contract. Your CSBG Contract requires your contract and deliverables to be completed and returned to your field representative within <u>30 calendars days</u> for private non-profit agencies and <u>45 calendar days</u> for public agencies from the date of contract release. Please note, unmet contractual requirements will be noted and reviewed for possible Correction Action in this year's Desk Review.

CSD is bringing this issue to your attention, specifically, because late contract executions are impacting internal workload, as well as putting CSD at risk to be out of compliance with Federal requirements. When initial contracts or amendments are not returned timely, it creates an additional workload on both CSD and agency staff to follow up with the status of these outstanding contracts. This puts CSD at risk of being out of compliance with Federal requirements by paying agencies during timeframes when there was "technically" no executed contract.

As of today, your 2023 Regular and 2022 Discretionary contract and deliverables are now 50 and 107 days delinquent, respectively. Please submit your Contracts and Deliverables via email by close of business Friday March 10, 2023. If you cannot meet this deadline or require assistance, please contact me at 916-594-2763.

According to CSAC, who is co-sponsoring the bill along with the California Association of Recreation and Park Districts, League of California Cities, Rural County Representatives of California, and the Urban Counties of California, AB 817 "would increase civic engagement by allowing members of non-decision-making legislative bodies that do not have the ability to take final action to participate in two-way virtual teleconferencing without posting their personal addresses while teleconferencing. Counties and other local governments have faced an ongoing challenge to recruit and retain members of the public on advisory bodies, boards, and commissions. Challenges associated with recruitment have been attributed to participation time commitments, time and location of meetings, physical limitation, conflicts with childcare, and work obligations, to name just a few. The COVID-19 pandemic drove both hyper-awareness and concerns about the spread of infectious diseases, as well as removed barriers to local civic participation by allowing this same remote participation. This enabled individuals who could not otherwise accommodate the time, distance, or mandatory physical participation requirements to engage locally, providing access to leadership opportunities and providing communities with greater diversified input on critical community proposals. The in-person requirement to participate in local governance bodies presents a disproportionate challenge for those with physical or economic limitations, including seniors, persons with disability, single parents and/or caretakers, economically marginalized groups, and those who live in rural areas and face prohibitive driving distances. AB 817 addresses these issues by providing a narrow exemption under the Ralph M. Brown Act for non-decision-making legislative bodies that do not take final action on any legislation, regulations, contracts, licenses, permits, or other entitlements, so that equity in opportunity to serve locally and representative diversity in leadership can be achieved." <u>AB 240</u> would establish the California Spay-Neuter Fund to finance low-cost spay-neuter operations throughout the state of California. The Fund would be financed through a \$200 annual charge to pet food manufacturers for each dog and/or cat food label they have on file with the State Department of Public Health. The fund will be managed by the California Department of Food and Agriculture (CDFA), which will distribute the money through competitive grants and/or set allocations. "Eligible partners" will include public animal shelters, private animal shelters with public contracts, and nonprofits for whom spay-neuter is a primary activity. Grant recipients must primarily use any money they receive for spay-neuter services. They will also be required to report annually on how they used the funds and the outcomes that use produced.

If the Board does not adopt a "Support" position on the bill, there will be no official advocacy position for Contra Costa County.
